In the month of August, we had revenue as follows, rent income from Meyers in Advo, plus a special, uh, lease arrangement, a temporary arrangement that we made with Starlight for the \$2,000. So the total rent was 36,439, and we collected \$150 on, as summas case totaling 36,589. The expenses were as follows, utilities of 31 89. Uh, just note that for that month, we did not receive the water bill. Um, the water bill was not issued, uh, uh, for at least a month or two behind, I would check online and it, it wasn't, um, delivered. So I, I paid it once they actually presented it. The accounting and review, uh, we incurred \$10,600. Michelle Diaz, 1500 plus the \$9,100 to Bruno and tur on for the annual review insurance of 38 37 to Noah Lewis. That was for the annual DNO and directors and offices, insurance, insurance and repairs and maintenance of \$43. It was a reimbursement to Commissioner Jefferson for door hardware supplies. The total expenses was 17,669, bringing net income for the month to 18,920. If you turn to the next page, it shows that our cash went up by that 18,920, bringing it to 1,059,783.

The revised budget reflects the, uh, work and, and decisions and recommendations that were made by the finance committee when we met on Wednesday. And so I'll go through these, um, where there are changes being recommended and provide, you know, whatever comments and insight I can as to what's driving the change. Um, the utilities reimbursement is one item I just want to address. Um, at the meeting we had discussed possibly needing to change that, but since then, um, I have had an opportunity to speak with both Meyers and Advo, and I feel very comfortable in speaking with them that they are going, they are in agreement. There is no pushback whatsoever on them remitting a reimbursement for the water bill. So, um, I'm recommending that we leave it at the 72,000 because I am fully expecting that, uh, between the two of them, we will collect the

remaining monies that are due for the, uh, utilities reimbursement. So the only change in the revenue line items would be the other income.

The accounting and review is, uh, exactly where we anticipated it would be. Um, the pest control we have not incurred. I did send out an email to the, uh, property committee a few days ago recommending that they at least engage a pest control company to do a termite service. So I've left that \$2,000 there in, in anticipation that the property committee will be able to move on at least getting a, a termite treatment at the building and would be the budget 2000 for the telephone. The finance committee recommended just a small adjustment to \$1,000. Again, when we have the uh, uh, administrative service person to come on, we are anticipating bringing on telephone line. And also they wanted to leave some dollars there. That's at \$1,000 website hosting just a small adjustment to nine to 900, just decreasing it by \$120. And then we have the miscellaneous contingency, which is just to cover anything else that should arise that will remain at 5,000. So the total revised expenses is 293,650, which is \$157,570 less than what we had projected at the beginning of the year. And so that will bring our net income for the year. We had projected that we would have a \$33,080 surplus. We would now have a \$190,050 surplus. So the difference is an additional 1 56, 9 70.

And what I don't want us to give back to, because it's grossly unfair to tenants who are paying rent that we allow the grass to get unmanageable. It, it is just not fair. And so something has to be done. Again, if the board does not feel comfortable today, it is my hope that this matter is gonna be handled expeditiously. But after December, that will be someone that across the bay commissioner better.
